Terry's Message

Two momentous accomplishments have occurred this past month: The Safe-Routes-to-School initiatives have been established for Pearson Ranch Middle School and Elsa England Elementary and the pedestrian bridge was "raised" 18' above Brushy Creek and mounted on its abutments.

Pearson Ranch Road Safe-Routes-to-School

Parents from Avery Ranch, my office, the County Engineer, Austin City Council Member Jimmy Flannigan's office (for Austin in Wilco), RRISD representatives, and a RRISD Trustee met in Avery Ranch on June 25, 2018 to discuss speeding on Avery Ranch Blvd., the unsafe Avery Ranch Blvd @ Pearson Ranch Rd. intersection, and congestion and lack of safe crossing across Pearson Ranch Rd. at the two schools.

Another meeting was held refining the regional desire for safety requirements and on February 15, 2019, I attended an entire morning at TxDOT in Austin in a Safe-Routes-to-School training for the grant program. Turns out that program really funds things like sidewalks (or widening) and bike paths/bike racks. Well – these schools had all these things but the students in every case had to cross Pearson Ranch Road which was inadequately planned from the beginning of time, and some middle schoolers had to cross Avery Ranch Road to reach Pearson Ranch Middle School.

Jimmy and I returned to our respective offices and started searching for money to fund making it safer to cross Pearson Ranch Road and Avery Ranch Road. After more meetings with Austin Traffic Engineer Dipti Borkar and much emails with all the shareholders, we had a final requirements meeting and the following happened:

- Jen Duthie, Austin Traffic Engineer, produced the design for Pedestrian Hybrid Beacons (PHBs) for crosswalk
- Jimmy, I, Terron Evertson, our County Engineer, and Hal Hawes, the Commissioners Court lawyer, hashed out an Inner-Local Agreement between Austin and the County.
- Garry Brown, my executive assistant, got it on the Court's agenda, and the Commissioners Court approved it in June.
- Garry got the signed agreement over to Jimmy's office where his staff got it through the Austin review process and Austin City Council's approval process. Then, it was the height of vacation season and it sat for review by legal (I'm assuming) for a while. Jimmy was able to get it cut loose and the work got started!

I want you to know the Austin team of engineers, Jimmy's office, our Road and Bridge workers and Austin's subcontractors teamed up like a well-oiled machine and made huge strides. Last step was working with Pedernales Electric Cooperative on electrical breaker, metering, final inspections and approval! We were more than anxious to celebrate and each day towards the end seemed longer and longer.

On October 25, 2019, we all got emails announcing that the PHBs should be turned on for school release that day. I was down in San Marcos at a Community Advancement Network symposium on education initiatives for preparing students for the workforce. I tore out of the event as soon as it was over and went straight to Pearson Ranch Middle School. I got there just in time to observe the elementary stragglers and vehicular traffic's response to the PHBs! The two crossing guards and I had our own small celebration!

Next, what will RRISD Traffic and Safety do about the over-burdened campuses sharing single roads for all those vehicles? In the three years of the middle school's existence, the population is now approaching capacity and the elementary school is way past capacity. The traffic patterns designed are no longer sufficient. Only RRISD can solve that.

We haven't forgotten about the traffic light going in at Pearson Ranch Rd. and Avery Ranch Rd. Much of the pre-work has been done. Just waiting on the mast arms on which the lights will be mounted to come in. Due to steel tariffs and only 3 manufacturers in the US, we will have to wait a few months before they arrive.

Oh, the saga, cheers for the progress. BCRT expansion from Round Rock to Fern Bluff was only partially funded with the 2013 Park Bonds program. It took acquiring a CAMPO grant (thru TxDOT) to complete the funding, however, there was a catch. The grant funding was by the mile of trail land the county owned by an early TxDOT deadline in February 2018.

This section of the BCRT was the trickiest with 24 parcels of property, much of them with commercial owners. Our right-of-way team from Sheets and Crossfield worked long hard days – they acquired 18 of the parcels and closed on them by early February. I was working with Randy Bell, our former Park Director, on negotiating with a Faith Missionary Baptist Church deacon on possible passageways across the property when the hammer fell on the deadline. We had 6 parcels with two property owners to go, so, between the cost of the ROW and the length of the fully funded, owned-by-the-county trail ROW, the length of the trail was reduced from 2.7 miles to .931 miles. Fern Bluff would remain a distant vision.

Then an intern writer from Community Impact wrote an ever-so brief article and included the phrase “the project will beginand end just before reaching Faith Missionary Baptist Church ...” Well, all heck broke loose on social media with the Church being publicly condemned. It wasn’t their fault – we hadn’t finished negotiations; certainly couldn’t go to closing prior to the TxDOT deadline. Furthermore, the Church owned both sides of Brushy Creek. This trail expansion was going to greatly change their pastoral setting, and we wanted to be careful and thoughtful about a route across their property.

The fervor that erupted became a roadblock and both sides of the negotiations took a hiatus.

The project went out for bid in early 2019. The project was awarded to Round Rock’s own Chasco Constructors and on March 18, they were given notice to proceed. The initial run from behind the old 620 Café west to the first river crossing for the trail looked like a scene in an equatorial country – dense vegetation made it hard to see where you were going, and the entire crew got poison ivy, oak and sumac! Then the monsoons of the spring and early summer further taxed the team. However, they were seasoned professionals and not easily daunted.

The excitement surged with the arrival of the pedestrian bridge created in two parts in Colorado and transported via two trucks/trailers to Round Rock on the morning of October 18. The combined weight was over 35 tons, 121 ft long when assembled, 16.5’ wide – imagine the ire of the drivers on the road with this taking 2 lanes. They had to plan the route accordingly. Once down on the north shore of Brushy Creek, a very large crane lifted each section off and with over 350 bolts the two sections were joined. Then, using only four cables, the crane lifted the bridge and slowly transported it higher and higher as each end was pulled into place on the abutments – still takes muscle and rope – and lowered into place right as the sun was dropping in the horizon. Fall colors were ablaze (as much as they do here). There is a video posted under “Hot Topics” on the [Commissioner 1 webpage on Wilco.org](#). 
This week they started pouring concrete and developing the boardwalks which will be ADA compliant to get you onto the bridge.

This trail section may be completed in March; yes, it does terminate at Faith Missionary Baptist Church. Please stop and turn around for now. It is to connect with the Round Rock trail to allow you to journey eastward across Round Rock along Brushy Creek. Currently, I have no construction data on that.

PS – we are working on a win-win scenario with the church. I have high hopes. Then to the last property owner, which is now two.

This month, Commissioner Cook, her staff, and a few other county employees witnessed a new trail bridge being put into place. The bridge was hauled down from Colorado in two pieces, bolted together on site, then lifted into place. As you can see in some of these pictures, it was a very tight fit coming around corners and into the staging area. LCRA had to be called in because the crane was near the powerlines. The people getting the bridge into place were consummate professionals. No major issues getting it into place!

It spans 121 feet and sits 18 feet above the surface of Brushy Creek. When this bridge opens, you’re going to feel like you are walking amongst the tree tops! Enjoy this sneak peek!




Where is Commissioner Cook?

Cook: Central Texas' aging population, caregivers need more services

According to the U.S. Census Bureau, the Central Texas regions hosts the second fastest growing population of adults 65 and older and the fastest growing population of adults 55 to 64.

The Aging Services Council of Central Texas reports that by 2040 more than a half-million seniors, or 517,772, will live in Bastrop, Caldwell, Hays, Travis and Williamson counties and comprise nearly 18 percent of the Central Texas population.

Many seniors already do or will rely on adult caregivers, who are often family members.

AGE of Central Texas, a nonprofit, operates licensed activity and health service centers in Round Rock and Austin for seniors. The Thrive Social and Wellness Centers provide daytime care for older adults with physical or cognitive needs, with 90% suffering from memory loss or dementia.

These centers also provide caregivers who are still in the workforce a place that is safe, engaging and active for their senior loved ones. They also serve as a place of respite for other caregivers.

On a typical day at one of the centers, members enjoy coffee, breakfast and conversation until about 10 a.m. After that, they can participate in activities scheduled throughout the day focused on both mental and physical stimulation.

The centers are open weekdays from 7 a.m. to 5:30 p.m.

In a 2018 survey conducted by AGE of 400 Central Texas residents, one in 10 consider themselves a caregiver to an older adult and three in 10 say they will be one in the future, while almost one in five are not sure.

October 6–12 was proclaimed as National 4-H Week in Williamson County. A few 4-H students across the county came to Commissioners Court to help celebrate.



Did you know that addiction is one of the most rapidly growing epidemics? Only 1.4% of people age 12 or older received treatment in 2018. 22.2% of Williamson County adults report excessive drinking.

October is Substance Abuse Prevention Month, and the week of October 24 -31 is Red Ribbon Week promoted by the LifeSteps Coalition, which encourages #iLiveRed- Resilient, Empowered, and Drug-free lives. Commissioner Cook was happy to sponsor this proclamation.

Road Updates

620 at Railroad/Chisholm Trail– Right of Way acquisition and design are complete. This is a TxDOT project with county and City of Round Rock financial assistance (cash only). STILL waiting on utility relocation, although we've been told this should be finished this month. Construction start is anticipated in early 2020.

Great Oaks Bridge at Brushy Creek Rd.– All plans are to be 100% completed in November. Drainage is being re-evaluated to meet federal newly released rainfall intensities in accordance to National Oceanic and Atmospheric Administration's (NOAA) ATLAS 14. US Army Corps of Engineers have approved the plan, but other approvals will be coming this fall. The construction is fully funded through the 2013 bond and is anticipated to begin Spring 2020.

Hairy Man Rd./Brushy Creek Rd. Safety Improvements– The Brushy Creek MUD, Fern Bluff MUD, and Commissioners Court have approved the Interlocal Agreement (ILA). Additional hydrologic and hydraulic mitigation of the project is completed. Right of way acquisition nearly completed for this 2013 bond project. Design work is done and under review. This is a safety project. The construction is fully funded, and the start is anticipated early 2020 pending right of way acquisition.

N. Mays St. Extension from Paloma Dr. to Oakmont Dr.– Embankment work at the south end of the project continues. The bridge, a long, 4-lane project over a flood plain, is being constructed; concrete beams and bridge deck panels are being installed. A wastewater line was installed to the north of Paloma Dr. and a concrete pipe was installed at the north end of the project. This is a joint project of the City of Round Rock and Williamson County that runs parallel to I-35 to take some traffic off of the interstate, and give the proposed Nutty Brown venue a 2nd entrance/exit. Substantial completion slated for Spring 2020.

University Blvd. widening from IH-35 to Sunrise Rd.– Design and right of way acquisition is complete, and utility relocation efforts are ongoing. Construction start is anticipated in late 2019. University Ave., which turns into Chandler Rd., takes you to Texas 95 north of Taylor, making this a very important East-West connector.

Pond Springs Road Area Drainage Improvements– A meeting with the City of Austin, TxDOT, and the Central Texas Regional Mobility Authority (CTRMA) has taken place to discuss shared use of a retention pond already in the area. The CTRMA is determining the maximum drainage capacity of that pond. Commissioner Cook made this one of her top 4 priority projects in Precinct 1 for the 2019 bond list. This has been a long-time drainage/flood area issue.

Forest North Drainage Improvements Phase III– A geologic assessment, karst survey, and an endangered species report have been finalized, as has a survey. Easement agreements are on-going, and meetings with residents to discuss and answer design questions continue. This project is Commissioner Cook's #1 Priority in Precinct 1 for the 2019 Bond Program. It is to complete the massive drainage program in this flat, slightly sloping neighborhood established in the 1970's and subject to flooding. **Anderson Mill zone is complete, and where sod was placed was at the suggestion and expense of the contractor. The additional work at Tottenham Ct. has begun with the excavation for the underdrain pipe. Substantial completion is anticipated Fall 2019.**


